### PRESIDENT'S MESSAGE

The salient item of news is the change in the Vice-Regal appointment for the Province of British Columbia. On 20 March came the official announcement that **The Honorable Judith Guichon, O.B.C.** was retiring. I immediately wrote Her honour to express our appreciation for Her Honour's patronage of our group.


I later received a reply from Her Honour, dated 9 April, expressing her pride with being associated with our Branch.

Our branch had previously presented Her Honour with a table shield; hopefully this will be displayed at her home as Her Honour returns to private life.

And we now have a new Vice-Regal with the appointment of **The Honourable Janet Austin, O.B.C.** as the new Lieutenant-Governor of B.C. The interesting aspect of Her Honour Janet Austin is that she is already armigerous; her arms were registered by the Canadian Heraldic Authority on 15 March 2013, Volume VI on page 217.

These arms were inherited from Her Honour's father, **Grey Howick Merivale Austin** (1922—2013) of Calgary AB.

Blazon Arms

Azure on a chevron engrailed between three Latin crosses Or, three roses Gules barbed Vert seeded Or;

Crest

Issuant from a wreath of dwarf poinciana flowers proper, a demi-lion Or charged on its shoulder with three gouttes de poix and holding in its dexter paw a Latin cross erablé Gules;

### Symbolism

#### Arms

The arms and crest are based on an 1852 grant by the English Kings of Arms to the Right Reverend William Piercy Austin, Bishop of Guyana (1807-1892) and to other descendants of his grandfather Col. Thomas Austin (d. 1806). In this version of the arms, the blue field represents the service of Ms. Austin's late father, Grey Howick Merivale Austin, as an officer in the Royal Navy during the Second World War. The three wild roses represent the Province of Alberta, where the late Mr. Austin had resided for most of his life. The passion crosses commemorate the service of Bishop Austin to the Church of England in the Caribbean and South America and his term as prelate of the Most Distinguished Order of St. Michael and St. George.

#### Crest

The cross of maple leaves indicates that these arms belong to a Canadian branch of Col. Thomas Austin's descendants; in addition, the maple leaves on the arms of the cross represent Ms. Austin's father's four Canadian-born children and four Canadian-born grandchildren. The three black drops honour her father's long career as a petroleum geologist. The wreath of Dwarf Poinciana flowers, the floral emblem of Barbados, represents her late father's Barbadian origins.

#### Motto

Meaning "A mind conscious of rectitude," this Latin phrase was first used by William Piercy Austin

### Blazon of the arms:


Gyronny Argent and Gules an orle gyronny Sable and Argent.

### Blazon of the Crest:

Issuant from a Loyalist military coronet Or a dexter arm embowed vambraced and holding a Maori patu proper.

The tinctures represent my life in Canada (Argent and Gules) and New Zealand Sable and Argent) with the divisions of the sub-ordinaries representing the various career and military service I have done on both countries.

The crest invokes my Canadian and British military heritage as well as New Zealand.
